FOREIGN ORDERS: We offer shipping to Canada and other foreign countries by UPS, Ocean Freight and Air Freight. All orders must be pre-paid. There are no COD or billing service available. All shipping and handling charges must be pre-paid. The carrier will collect any other export/import fees and duties.

FREIGHT: Prices do not include freight charges. Special prices or discount will not qualify for free freight.

DROP SHIP: All drop ship orders are subject to a \$10.00 handling fee.

CLAIMS: All merchandises are packed carefully and correctly utilizing a triple check method before it leaves Empire Tire Group facility. Damaged shipments should be checked in the presence of the carrier. All claims for damage or loss to your shipment must be made with the carrier within 24 hours. Please keep all shipment cartons and packing material for carrier inspection Empire Tire Group will not initiate any claims with the carrier. Claims for shortage of items or damaged shipments must be made within 2 working days or receipt.

TERMINATION: Empire Tire Group reserves all the right to terminate any account that does not meet the required terms and conditions.

LEGAL VENUE: In the event that legal proceeding are required to resolve dispute or indifferences, all claim and filing must be made with Florida Supreme Court in Miami, FL.
